RESOLUTION NO. 2 of 2015

RESOLUTION OF THE EAST ORANGE PARKING AUTHORITY APPROVING PARKING VIOLATION REVENUE AGREEMENT BETWEEN THE AUTHORITY AND THE CITY OF EAST ORANGE

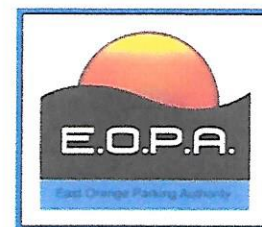
WHEREAS, in order to investigate, implement and manage strategies regarding parking and traffic management issues, the City Council (the "City Council") of the City of East Orange (the "City"), pursuant to Ordinance No. 14-1970 duly adopted March 9, 1970 (the "Creation Ordinance") and the Parking Authority Law (N.J.S.A. 40:11A-1 *et seq.*) of the State as amended and supplemented (the "Act"), created and established the East Orange Parking Authority (the "Authority") as a public body corporate and politic of the State and an agency of the City with all the powers, privileges, and authority conferred by the Creation Ordinance and the Act; and

WHEREAS, as set forth in the Act, the purposes of the Authority are, among other things, to: (i) construct, provide and/or operate off-street parking facilities, (ii) manage and operate on-street and other parking meters and related facilities, (iii) enforce applicable law, ordinances and regulations as to the parking of vehicles in the City and (iv) thereby promote the free movement of traffic and relieve traffic congestion on the streets of the City and improve conditions affecting the public safety and welfare therein; and

WHEREAS, by Ordinance No. 21 of 1972 (the "Authority Powers Ordinance"), in order to assist the Authority in carrying out its public purposes, the City pledged to, and covenanted and agreed to, pay to the Authority "all of the funds received by the City for and with respect to the parking or storage of motor vehicles in the streets of the City or otherwise, including funds collected in the parking meters located in or along such streets or otherwise"; and

WHEREAS, pursuant to N.J.S.A. 40:11A-22(a), the City may agree with the Authority to pay to the Authority all or any part of funds received by the City for or with respect to fines associated with violation of regulations applicable to parking or storage of motor vehicles; and

WHEREAS, in order to further assist the Authority in carrying out its public purposes, the City desires to share a portion of the revenues derived from the enforcement, by the Authority, of the applicable law, ordinances and regulations as to the parking or storage of motor vehicles in the City; and



WHEREAS, toward that end, the Authority desires to approve the execution of that certain Parking Violation Revenue Agreement by and between the City and the Authority (the "Parking Violation Revenue Agreement").

NOW, THEREFORE, BE IT RESOLVED by the East Orange Parking Authority as follows:

1. The aforementioned recitals are incorporated herein as though fully set forth at length.
2. The Authority hereby authorizes and directs the Chairman of the Authority to execute the Parking Violation Revenue Agreement in substantially the same form as that on file with the Authority, along with such additions, deletions and/or modifications as the Chairman shall deem necessary in order to effectuate the intent of this Resolution.
3. This resolution shall take effect immediately.
