## RESOLUTION NO. 8 OF 2016 EAST ORANGE PARKING AUTHORITY RESOLUTION AUTHORIZING THE PURCHASE OF A MOTOR VEHICLE

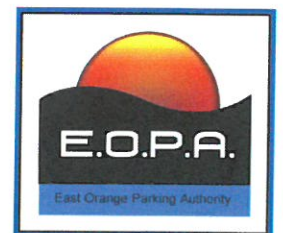
WHEREAS, access to and control of an additional motor vehicle has been determined necessary to meeting the Authority's responsibilities for enforcement of parking policies and regulations; and

WHEREAS, it is desirable to have such additional vehicle available to the Authority as soon as practical; and

WHEREAS, a selection of vehicles suitable to the Authority's purposes is available at advantageous pricing through various "State Contracts" or possibly other methods of procurement allowed pursuant to the NJ Local Public Contracts Law and related regulations;

NOW, THEREFORE, BE IT RESOVED THAT the Chairman is authorized to approve the procurement of a vehicle suitable to the above-stated purpose and through means allowed pursuant to the NJ Local Public Contracts Law and related regulations; provided

THAT the cost of said vehicle along with related options and functional fit-out such as vehicle graphics, emergency lighting and other such equipment shall not exceed the sum of \$25,000.
