## RESOLUTION NO. 1 OF 2013

RESOLUTION OF THE EAST ORANGE PARKING AUTHORITY AS TO THE REVIEW, ACCEPTANCE AND AUTHORIZATION OF THE SUBMISSION OF THE ANNUAL REPORT OF AUDIT TO THE LOCAL FINANCE BOARD

WHEREAS, such Resolution of Certification shall be adopted by the Authority no later than forty-five days after the receipt of the Annual Audit, as per the regulations of the Local Finance Board; and

WHEREAS, all members of the Authority have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board; and

WHEREAS, failure to comply with the promulgations of the Local Finance Board of the State of New Jersey may subject the Commissioners of the Authority to the penalty provisions of R.S. 52:27BB-52 - to wit:

R.S. 52:27BB-52 - "A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall for eithes office."

NOW, THEREFORE, BE IT RESOLVED by the East Orange Parking Authority as follows:

- 1. The aforementioned recitals are incorporated herein as though fully set forth at length.
- 2. The Commissioners of the Authority hereby state that they have complied with the promulgation of the Local Finance Board of the State of New Jersey and the Authority does hereby submit a certified copy of this Resolution and the required Affidavit to said Board to show evidence of said compliance.
  - 3. This resolution shall take effect immediately.
